General principles and requirements:

- The programme is aimed at unemployed graduates who have successfully completed at least a three (3)-year Degree/ Advanced Diploma OR students who have passed all course work but require practical workplace exposure for completion of a qualification in any field specified above.
- Preference will be given to candidates who have obtained a minimum 60% aggregate pass mark at undergraduate level (final year) and a minimum 55% pass mark at post graduate level. Candidates must indicate their undergrad and/ post graduate aggregates on their CVs.
- Applicants are only opened to South African citizens between the ages of 18 and 35 years.

- Applicants who have benefited from an internship programme and have previous formal employment in the field of study will not be considered.
- GEPF will not make provision for accommodation to any candidate attending the interviews or appointed candidate.
- GEPF will ensure that its selection and recruitment process is employment equity compliant. Preference will be given to people with disabilities.
- If after your appointment it is established that you have given false information, this may lead to a termination of contract.
- Correspondence will be limited to short-listed candidates only. If you have not been contacted within 1 month after the closing date, please consider your application as unsuccessful.
- Applicants must apply only for positions that are in line with their qualifications.
- Applicants must indicate the institutions they studied at on their CVs.
- Preference will be given to individuals who have studied at previously disadvantaged institutions of higher learning.
